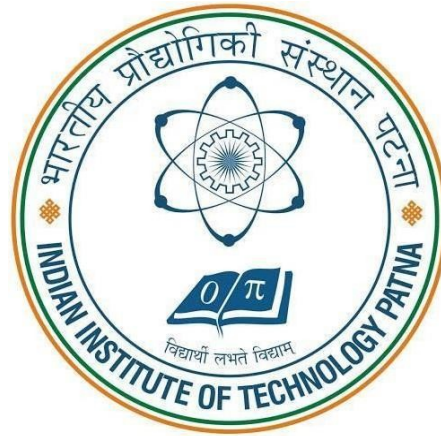

6. **Bidders need not come at the time of Technical as well as financial bid opening at IIT Patna. They can view live bid opening after login on CPP e- Procurement Portal at their remote end. If bidder wants to join bid opening event at IIT Patna then they have to come with bid acknowledgement slip that generates after successfully submission of the online bid.**

Average Annual Turnover for last three financial years i.e. 2018- 19, 2019-20 and 2020-21 should not be less than 50 % of the estimated cost & Should not have incurred any loss in more than two years during the immediate last five consecutive financial years, ending 31.03.2021.
